Management Education Capacity Building

We help universities in low- and middle-income countries build their capacity to offer management education programs through improved curricula, faculty development, and the introduction of new pedagogical tools and techniques. WDI leverages best practices from our home base at the University of Michigan and customizes solutions based on local contexts.

Management Educating Training

Through our deep knowledge, expertise and networks, we provide innovative and practical management training programs in emerging markets. We conduct in-person and virtual programs which connect and equip learners from around the world. Since 1992, we have trained over 19,000 participants from thousands of companies and non-profit organizations around the world.
